Norman Abbot Gosline was born on November 6, 1935 in Gardiner, Maine, the son of Arthur N. and Katherine R. (Wadsworth) Gosline. Mr. Gosline received his Bachelor at U. Maine in 1957. Realtor A.C. Brooks & Company, 1959-1960. Principal Gosline & Company, Gardiner, 1960. Member of faculty (part-time) at UMaine, Augusta, 1973-1981.

Consultant in real estate to various agencies and firms in Northern New England, 1965. Selected for real estate team visit to People's Republic of China, Citizen Ambassador.

Program of People to People. Past member Gardiner Planning Board Named Realtor of Year Kennebec Valley Board Realtors, 1967.

Membership: Past member Gardiner Planning Board ambulance advisory committee. Member American Institute Real Estate Appraisers (president Northeast chapter 1985), Society of Real Estate Appraisers (president Maine chapter 1975-1976, 81-82), Appraisal Institute (director 1993-1996), National Association Realtors (board directors 1967), Maine Association Realtors (president 1967), American Society Real Estate Counselors, Kennebec Valley Board Realtors (president 1963-1964, Realtor of Year 1967), Rotary (Paul Harris fellow), Shrine.<sup>1</sup>

### Scope and Content

This collection consists of seven binders of Real Estate Appraisals between 1972 and 1999 by Mr. Norman A. Gosline which are public files from Towns, Counties, or State. Four binders are appraisals of properties in the Fort Kent area, which includes two appraisals of the Town of Fort Kent Community Development Project in 1976 and 1977 requested by Claude Dumond and James R. McClure, Town Managers in Fort Kent at the time. Included at the end of some Appraisal Reports are Sale Summaries, from public records used for comparison purposes. Photographs of properties and/or dwellings are included.

Two binders contain an appraisal and an appraisal update of the Midtown Shopping Center in Madawaska, Maine, and one binder has an Appraisal of Property of Mary Mediatrix Convent, which is the Inn of Acadia in Madawaska today. There is mention of some Retail Leases in the Van Buren, Caribou, and Presque Isle areas at the end of some reports used for comparison purposes. Included are a Plan of Property and a Plot Plan showing location of the Midtown Shopping Center, which were taken out of this binder, unfolded, and placed separately in a larger folder.
