## **Collection Description**

Historical and Biographical Information

The Northeastern Boundary dispute was a result of unresolved borders between the present day United States and New Brunswick, Canada after the Revolutionary War and the Treaty of Paris (1783). At the start of this dispute, Maine was a part of the Commonwealth of Massachusetts, which granted land deeds to citizens in regions of present day Northern Maine where British citizens had also laid claim to land. Negotiations soon started between the two countries to determine where the border would fall. Over the years, the defined lines of the border changed depending on which side commissioned cartographers to draw up maps and where negotiations stood.<sup>1</sup>

When Maine became its own state in 1820, the issues of its northern boundary became a more pressing issue to resolve, especially with the Commonwealth of Massachesetts claiming a percentage of Maine lands as part of its agreement for granting Maine statehood. Tensions continued to grow. Then, in 1839, the American and Maine governments set aside troops and money to commit to the boundary issue and forts were erected on either side of the Saint John River, which at the time, marked the northern boundary between Maine and New Brunswick. This is considered the start of the Aroostook War, though it is considered a bloodless war as no physical battles were fought or casualties recorded as a result. In 1842, the Webster-Ashburton Treaty was signed, settling the boundary dispute between Maine and New Brunswick.

The original manuscripts consisted of 24 volumes that were digitized onto 12 microfilm rolls by the Maine State Archives on behalf of the Maine State Library. In the 1990s the Acadian Archives acquired copies of these rolls for their own collection. The originals are still held by the Maine State Library in Augusta, Maine.
