Biographical information:

Rita is the daughter of Walter Stadig and Bertha Saucier, granddaughter of Olaf Stadig. She has 3 brothers, Bennett, Kennit, and Willis Stadig. She lived in Soldier Pond, Maine. As of today, Rita resides in Houlton, Maine She has written many books just to name a few: *Aroostook War; The St. John Valley Story; The Ski Marathoners; Our Maine Heritage*. Rita never married. Rita's father, Walter Stadig, was a game warden, a lumberman, he was the inventor of the rotary snow plow. He also participated in the Bangor to Caribou ski marathon of 1936-1937. Walter died in 1952.

Scope and content:

This collection consists of a variety of papers and photographs pertaining to the Stadig family and the history of the St. John Valley. The materials cover topics such as the lumber industry, Sweden and the Swedish colony of Aroostook County, World War II and the Fish River; Fort Kent, Wallagrass, and Madawaska are also represented by items in the collection. Processing action:

Folder 1: all photographs and copies of photographs were taken out of the album and inserted in clear plastic sleeves for preservation.

Folders 2 & 3: Archival quality staples were used instead of regular staples.

Folder 4: The album was dismantled. All images, articles, photos were unstapled and placed in plastic sleeves for preservation. The same order was kept as in the album.

Folder 5: archival quality staples were used

Folder 6: all documents and photographs were placed in clear plastic sleeves.
