Conservation Notes

The scrapbook pages of the First National Bank are made of black construction paper measuring 9 in. x 11 in. with multiple documents glued to each page. The documents were unfolded but left in the scrapbook due to their delicate nature. An attempt to unglue the pages will result in tearing and losing information, therefore, no attempt was made to unglue the pages from the scrapbook. (See inventory of the scrapbook to see multiple documents on each page). A photocopy of the scrapbook was made due to its poor condition. Page numbers were lightly penciled in on each page of the original scrapbook.

All photographs were inserted in polyester archival sleeves for protection and preservation and placed in archival albums except for two larger photographs that were placed in an oversized box. Other insurance documents were unfolded and placed in polyester sleeves for protection.

Collection Description

Historical and Biographical Information

The **First National Bank of Fort Kent**, Maine was organized by Paul D. Thibodeau on July 7, 1919. It commenced doing business on December 10, 1919 with a capital of \$25,000.00. The officers elected were Paul D. Thibodeau as President; Henry W. Nadeau as First Vice-President; Fred E. Michaud as Second Vice-President; and Arthur A. Herbert as cashier. The Directors were Paul D. Thibodeau, Henry W. Nadeau, Fred E. Michaud, Irenee Cyr, Ulderic Dumond, Maxime P. Gagnon, Albert R. Michaud, Saul Michaud, T.T. Michaud, Cleophas Nadeau, Philip A. Roy, William L. Savage, T.A. St. John, Frank A. O'Connell, Henry W. Theriault.

Thibodeau's Insurance Agency in Fort Kent, Maine was founded by its first insurance agent, Paul D. Thibodeau. Mr. Thibodeau started selling insurance for the Perry Agency of Presque Isle out of his home. A few years later, he established the Thibodeau's Agency with an office in the Fort Kent Trust Co. (old town office building) in 1902.¹

Paul D. Thibodeau was born in 1880 in Grand Isle, Maine to Vital Thibodeau and Methaide Duplessis. He moved to Fort Kent in 1904 and married Mary Alice (Mamie) Nadeau in 1906. He founded Thibodeau Insurance Agency in 1902. It's the oldest running business in Northern Maine and as of this date, is operating under United Insurance. Mr. Thibodeau also became the distributor for Maxwell Automobiles throughout the valley and onto Fort Fairfield, Portage, Ashland, Stockholm, and New Sweden. Mr. Thibodeau was a member of the Board of Directors and President of the First National Bank of Fort Kent. He served as town treasurer in 1913, was elected to the legislature in 1915, and became president of the Fort Kent Historical Society. He authored a pamphlet on the early history of Fort Kent, which the bank published. Paul died in 1938.

Other members of the Board of Directors at the time were: Irenee Cyr of Fort Kent, Ulderic Dumond of Fort Kent, Maxime P. Gagnon, Albert R. Michaud of St. Agatha, Fred E. Michaud of Fort Kent, Saul Michaud of Eagle Lake, T.T. Michaud of Soldier Pond, Cleophas Nadeau of Fort Kent, Henry W. Nadeau of Fort Kent, Frank A. O'Connell of Eagle Lake, Philippe A. Roy of Fort Kent, William L. Savage, Theodule A. St, John of Fort Kent, Henry W. Theriault of St. Francis, Maine.²

Irenee Cyr represented Fort Kent in the State legislature in 1911, 1913, 1949, 1953, and 1955. He was named postmaster in Fort Kent where he served for seven years. In 1920 he helped organize the First National Bank of Fort Kent and was its first cashier. With the help of colleagues, he was able to bring the registry of deed's office to Fort Kent. He was prominent in the civic affairs of the town, serving as chairman of the school board for many years, and trustee of Community High School District no. 1; the first of its kind in the state. He was married to the late Elodie Pinette. He remarried to Phoebe Boutot Cyr.³

Ulderique/Ulderic Dumond was born on October 27, 1865 in Fort Kent, Maine. He married Catherin Pinette in 1892. They were the adoptive parents of Mattie Pinette who served as Gerald Dwight Eisenhower's personal secretary during the planning of the D-Day invasion of Normandy during World War II. He owned a construction business in Fort Kent.

Maxime P. Gagnon (1874-1933) was born in Fort Kent, Maine, on July 10 1874 to Etienne Gagnon and Eleanore Pelletier. Maxime married Anastasie Chasse.

Albert R. Michaud was born on October 6, 1886 in Frenchville, Maine to Michel and Mary (Brown) Michaud. When he made his home in St. Agatha, he was a farmer, a starch manufacturer, and owned a general store that sold everything from food and clothing to furniture. He married Zenaide Audibert. Mr. Michaud served as postmaster for 23 years, town manager for 5 years, and was a representative to the state legislature as a Republican chairman. He was one of the directors of the First National Bank of Fort Kent, a past fourth degree Knight of Columbus, and belonged to the Woodsmen's Insurance Company of America.

Fred E. Michaud of Fort Kent graduated from the Madawaska Training School in 1902. He was treasurer for the Town of Fort Kent. Mr. Michaud served as the second Vice-President of the First National Bank of Fort Kent.

Saul Michard of Eagle Lake was in the graduating class of 1905 of the Madawaska Training School under Mary Nowland. Eagle Lake Camps, the first sporting camp opened in Eagle Lake, was opened in 1921 and managed by Saul. Mr. Michaud was also a deputy sheriff for Aroostook County as per the Maine Register or State Yearbook and Legislative Manual.

Thomas T. Michaud, the youngest son of Damase and Clara/Clarisse (Madore) Michaud, was born on June 14, 1885 in Wallagrass, Maine. He was educated in the public schools of Wallagrass and at the Fort Kent Training School and from his 19th year had been engaged in the mercantile business. He was located at Soldier Pond, where under the name T.T. Michaud, he conducted a newly built large store that was located opposite the Bangor & Aroostook Railroad station. His line embraced heavy and shelf hardware, paints, varnishes, mechanics' tools, lumbermen's supplies, guns, ammunition, fishing tackle, and the usual farming supplies. He was a large landowner and farmer as well as one of the heavy potato purchasers of the county. He was a prosperous, progressive, keen, modern business man, upright and honorable, highly regarded by all who knew him. During WWI, he served on the committee of public safety for his town and was a Republican in politics.

Mr. Michaud married Nellie (Lilly) Martin on August 27, 1906 at Frenchville Maine. Nellie was the daughter of Basil and Clara/Clarissa Martin. They had seven children: Corinne, Mamie, Chester, Wilbert, Gordon, Arthur, & Camile. T.T. was a wealthy man who was a farmer, logger, and property owner. Between the years of 1909-1910 he and his wife built the large Michaud home and then the family general store beside it shortly thereafter. The store served as a potato brokerage for local potato growers and as a general store for the community.

Mr. Michuad's wife, Nellie, took over ownership of the home, store, and properties in 1920 by the decree of a court order following their divorce. In 1922 Nellie deeded the house to her seven minor children, possibly to secure their inheritance. Sometime after 1924, Nellie gave the store and the land it was built on to the Catholic Dioceses of Portlant, Maine. Today, St. Joseph's Catholic Church occupies the place of the general store.⁵

Cleophas Naduea and his brother Esdras Nadeau moved to Fort Kent in 1882 to start a furniture-making business. Together they were the owners of Nadeau Furniture store. When Esdras Nadeau died in 1896, his brother continued to run the store alone until his nephew, Esdra's son Alphee Nadeau, took it over in 1914. By then the business had expanded to providing caskets and coffins in addition to "funeral services" in which the Nadeaus would dress the deceased, and provide the casket for a burial. "His uncle had sent Alphee to an embalming school in Boston in 1925 and at that point, they were licensed and could do the embalming. By 1928 Alphee Nadea had taken over a business that met virtually every consumer need in town." 6

Henry W. Nadeau was a well-known and popular postmaster of Fort Kent, Maine and the owner of a general store and a blacksmith shop. He was the son of Joseph Nadeau and Alice E. White. Henry was born on February 2, 1856 in Fort Kent. Upon completing his studies, Mr. Nadeau entered his father's mercantile establishment and remained as his father's assistant until his death when he assumed the management and operated it for 24 years. He was interested in farming and has carried on successful agricultural operations. Mr. Nadeau opened a blacksmith's shop at Fort Kent. For 12 years he served as postmaster for Fort Kent and has held the offices of assessor of the village, and selectman of the township. Henry married Zeline Audibert on January 7, 1882. He was a stockholder in the Fort Kent Telephone Company that was chartered on June 15, 1895. He was the first Vice-President of the First National Bank of Fort Kent.

Frank A. O'Connell- no information at this time.

Philippe A. Roy was born on September 24, 1879 to Philippe Roy and Marie Tardif. He saw a need for a general store so in 1920 he built a two story red brick building with a full cellar. They sold items such as matches, nails, saws, animal feed, and groceries. The building still stands today as the corner of Market Street and Main Street in Fort Kent, Maine. Philippe was married to Lena Thibodeau. He died on April 10, 1954.

William L. Savage was a store owner and mailman. He was born in June 1864 and married Edith Daigle in 1892. Mr. Savage died in Fort Kent in 1925.

Theodule A. (Alphonse) St. John was born October 13, 1877 in Castonguay Settlement, Maine to Nyzaire Isaie and Chrstine Ouellette. Jean was his actual first name, listed as his marriage by the priest as Jea-Theodule. He died on December 11, 1962 in Fort Kent, Maine. Like his dad, T.A. had to learn to be independent from a young age. He was the youngest of six kids, and life was tough in the Allagash. Isaie died when T.A. was 11 or 12 years old. None of his older siblings could take him in when Christine remarried a man named Hunter in 1890, and

apparently left. Theodule was raised by the Cunliff family. He worked in the lumber camps from an early age, working as a cook's assistant and working the spring log dives.

He came to Fort Kent at about the age of 19 and enrolled in the Madawaska Training School, intending to be a teacher, but never finished the program. He married Clara Michaud on August 8, 1901 and settled as a potato farmer, general store owner, and lumber buyer.

Henry W. Theriault (1879-1947) was born on November 17, 1879 to Muchel Theriault and Marie Boutot. Henry married Agnes Daigle (1887-1984) in 1906. Henry died on November 10, 1947.

Scope and Content

This collection consists of a scrapbook, photographs, Thibodeau family genealogy, Thibodeau's insurance documents, stenographer/shorthand booklet, and newspaper articles. The scrapbook belonging to Mr. Paul D. Thibodeau contains correspondence, meeting minutes, resolutions, and newspaper articles regarding the organization of the First National Bank of First Kent in Fort Kent, Maine. The correspondence is mostly between the President of the bank, Mr. Paul D. Thibodeau and the office of Currency at the Treasury Department in Washington D.C. The bank was organized by Paul D. Thibodeau on July 7, 1919. The officers elected were as follows: President, Paul D. Thibodeau; 1st vice president, Henry W. Nadeau; 2nd vice president, Fred E. Michaud; cashier, Arthur A. Herbert; directors. Paul D. Thibodeau, Henry W. Nadeau, Fred E. Michaud, Irenee Cyr, Uldereic Dumond, Maxime P. Gagnon, Albert R. Michaud, Saul Michaud, T.T. Michaud, Cleophas Nadeau, Philip A. Roy, William L. Savage, T.A. St. John, Frank A. O'Connell, Henry W. Theriault.
