Biographical information: JOHN FAIRFIELD, Maine's thirteenth and sixteenth governor, was born in Saco, Maine on January 30, 1797. His education was attained in the common schools of his native state and later at Bowdoin College. He studied law, was admitted to the bar in 1826, and established his legal career, serving as the reporter of decisions for the Supreme Court of Maine from 1832 to 1835. Fairfield entered politics in 1835, serving as a member of the U.S. House of Representatives, a position he held until 1838. He won the 1838 Democratic gubernatorial nomination and went on to win the general election. He was reelected in 1839, 1841 and 1842. During his tenure, the Aroostook War erupted over the long-disputed boundary quarrel, and the state militia was summoned to safeguard the contested land. Upon his election to the U.S. Senate, Fairfield resigned from the governor's office on March 7, 1843. He served in the senate until he passed away on March 7, 1847. Governor John Fairfield was buried at the Laurel Hill Cemetery in Saco, Maine.¹

Biographical information: Frederick Ansel Wood the son of Daniel Wood and Miriam Bodwell, was born on March 12, 1811 and died on July 14, 1871 in Lebanon, Maine. He married Mary Libbey on August 28, 1831 in Lebanon, Maine. He was a House Representative in 1843 and a Senator in the State Legislature in 1845.

Frederick's grandfather, Daniel Wood (1739-1819), came from England to Ipswich, Massachusetts, about the middle of the 17th Century and held various public offices in the colony, including membership in the Executive Council of Maine. Daniel Wood was a major in the Revolutionary War.

Historical notes: The militia's purpose was to uphold the law and the Constitution. Prior to the creation of the National Guard of the United States, the United States armed forces consisted of a relatively small professional, full-time military supported by state militias. During the War of 1812, the relatively large size of the various Maine militias was enough to discourage enemy interventions on the Maine coast. From 1820-1861 the militia was providing insight into the peacetime administration of the State militia and some records reveal Maine's response to the border troubles led to the Aroostook War of 1839.

Scope and content: This collection consists of one two-sided document signed by John Fairfield, Governor and Commander-in-Chief of the State of Maine, for the 1840 appointment of Frederick A. Wood of Lebanon, as Ensign in the State Militia around the time of the Aroostook War. The document is signed by Philip C. Johnson, Secretary of State at the time, and by A. B. Thompson Adjutant General. On the reverse side of the document, within a paragraph, appears the name of Jeremiah Butler, Colonel of the said Regiment. The document measures approximately 16 in. x 10 in. with the State of Maine seal embossed in the top left corner.
