Historical Note

The First National Bank of Fort Kent was purchased in 1955 by Northern National Bank of Presque Isle, Maine. In 1972, Northern National Bank merged with Casco Bank to become Casco Northern Bank, which operated in Fort Kent until 1992, when Casco Bank sold its Northern National Bank interests to Key Bank of Maine.

Scope and Content Note

This collection consists of two bound volumes of minutes of meetings of the Board of Directors of the First National Bank of Fort Kent, with inserted loose leaves of typed and handwritten notes and correspondence. An item level inventory of inserted items is available.

Provenance

The earlier volume (UB-007 1/2) was given to Richard Morin by the daughter of Irene Cyr, one of the original directors of the First National Bank of Fort Kent. The later volume (UB-007 2/2) was rescued by Mr. Morin when inactive administrative records were being discarded by Casco Northern Bank, First National's successor. Mr. Morin donated both volumes to the Acadian Archives/Archives acadiennes on 14 July 1992.
